

### 2022 ANNUAL REPORT

#### **DEAR MEMBER,**

Once again, Craighead Electric Cooperative Corporation continued its commitment to member service in a financially responsible manner. Our operating margins of \$3,254,091 were adequate to meet the requirements of mortgage agreements. Member equity in the system was 38.84% percent at the end of the year. Members were refunded \$2,399,050 in cash to redeem patronage capital credits. The 2005/2006/2020 redemption brings the total capital credits refunded to members to \$27,149,122.

Thomas, Speight, & Noble, CPA audited our financial records. You are welcome to examine that report.

System statistics of interest include: average meters served, 31,203, a net increase of 113 meters; more than 4,986 miles of power lines; 569,111,930 kilowatt-hours used by members, down 24,051,923 kilowatt-hours from the previous year; a system peak demand of 187,607 kilowatts, recorded in the month of December; and a net plant valuation of \$245,739,275 at year's end.


